English Pantomime

1.	<p>ELIGIBILITY – A cast shall consist of competitors who must be 26 years of age or under on 1 September 2011 and full members of a Club affiliated to NFYFC.</p> <p>Competitors will be required to show their YFC Membership Cards. Failure to produce a card will result in a penalty charge plus verification on the YFC database prior to being allowed to compete. Any member whose name is not listed as a current paid up member of the Federation and who cannot produce a membership card at the start of the competition will not be allowed to compete.</p>										
2.	<p>HEALTH AND SAFETY & CHILD PROTECTION – All competitions carried out at County level must comply with Health and Safety legislation and meet the relevant safety standards. The completion of a Parental consent form, for members under the age of 18, is the responsibility of the Club.</p> <p>All teams must abide by the Health and Safety Regulations and fire regulations of the theatre. All stage scenery must be fireproofed. NO LIVE ANIMALS OR STRAW TO BE USED!!</p>										
3.	<p>One over YFC age accompanist may be used but MUST be sited off stage and take no other part in the production.</p>										
4.	<p>PROCEDURE –</p> <p>The competition shall take the form of a pantomime, which may be either extracts from a pantomime* or the team’s original work.</p> <p>“Pantomime is a dramatic entertainment loosely based on a traditional fairy tale in which the activity is carried on with the help of singing, dancing, clowning, topical jokes and music, in which the performance of that action is conducted by certain stock roles, usually ‘principal boy’ (hero) acted by a woman, and the ‘dame’ acted by a man.”</p> <p>The pantomime can be adapted or rewritten for the Club/County and may also take the form of several pantomime story lines combined.</p> <p>CONTENT/MATERIAL (TASTE/DECENCY)- Material of a questionable nature will be penalised. Teams are reminded that they will be performing to a family audience.</p> <p>Producers/writers must carefully consider how taste, sexual matters, violence and strong language is dealt with. Every audience includes people of different ages (including young children), cultures and religions and this should be remembered.</p>										
5.	<p>TIMING Platform time allowed will be between 30 and 60 minutes. This must include setting and striking the set. If the total platform time exceeds 60 minutes, teams will have marks deducted at the rate of two points per minute, or part thereof.</p>

HALF AN HOUR OF ENTERTAINMENT COMPETITION RULES

1. **ELIGIBILITY** - A team shall consist of members each of whom shall be 26 years of age or under on 1st September 2011 and full members of a club affiliated to the NFYFC.
Competitors will be required to show their YFC Membership Cards. Failure to produce a card will result in a penalty charge plus verification on the YFC database prior to being allowed to compete. Any member whose name is not listed as a current paid up member of the Federation and who cannot produce a membership card at the start of the competition will **not** be allowed to compete.
2. **HEALTH AND SAFETY & CHILD PROTECTION** – All competitions carried out at County level must comply with Health and Safety legislation and meet the relevant safety standards. The completion of a Parental consent form, for members under the age of 18, is the responsibility of the Club.
NO LIVE ANIMALS OR STRAW TO BE USED!!
3. **BACKSTAGE** - A maximum of six helpers who need not be of membership age will be allowed. There is no restriction of helpers who are of membership age. All helpers who are visible on stage must be YFC members.
4. Live musical accompaniment, whether on or off stage, must be by a YFC member(s) (not Associate Member), BUT a maximum of one musician may be over YFC age BUT must be sited off stage and take no other part in the production. Taped sound effects/music permitted. (Carms YFC cannot be held responsible for the efficiency or quality of any sound system in any hall/theatre used).
5. **COPYRIGHT** is the responsibility of the Competitors.
6. **PROCEDURE** – The competition shall take the form of an entertainment (see guidelines attached) but must NOT take the form of a play.
7. Material of a questionable nature will be penalised.
8. **TIMING** – Platform time allowed will be up to 30 minutes. This must include setting and striking the set. If the total platform time exceeds 30 minutes, teams will have marks deducted at the rate of two points per minute, or part thereof, over 30 minutes.
